UNITED STATES VS. ANTOINE JONES

United States v. Jones, 132 S. Ct. 945,565 U.S. (2012), was a United States Supreme Court case which held that installing a Global Positioning System (GPS) tracking device on a vehicle and using the device to monitor the vehicle's movements constitutes a search under the Fourth Amendment. In 2004, defendant Mr. Antoine Jones was suspected of drug trafficking. Police investigators applied for and received a warrant to attach a GPS tracking device to the undercarriage, of the defendant Jones' vehicle. After receiving the warrant, the police investigators exceeded the warrant's scope in both geography and length of time. The Supreme Court justices voted unanimously that the police investigator's action constituted a "search" under the Fourth Amendment, of the United States' Constitution. The majority held by physically installing the GPS device on Mr. Jones' car, the police had committed a trespass against Mr. Jones' "personal effects" - this trespass, in an attempt to obtain information, constituted a search per se. -News Coverage by The Washington Post, The Washington Times, The Examiner Washington and Local Television News Stations

SYNOPSIS:

Antoine Jones' hard upbringing and determination to be anything but broke, led him to the life and title of one of the largest drug Kingpins, in Washington, D.C. The naked truth, supported by case records and Jones' actual experience, showcases, and explains a corrupt legal system whose prior jury delivered a guilty verdict and imposed a sentence of life in prison. After several trial rounds of misguided, twisted, and ambiguously lopsided testimony and evidence, Antoine had endured more than he could stand.

The first episode introduces the initial arrest of Antoine Jones, the Pro

Se Litigator himself, as well as the arrest of his Club Levels (Night Club) codefendants, his associates, and three Mexican drug cartel members.

Secondary unrelated arrests include Charles "Black" Walker, a street thug big time D.C. drug dealer, as well as several others who played significant roles in the D.C. street-life, while they are housed in D.C. Jail, pending court proceedings.

Black's role throughout the first two seasons of The Pro Se Litigator series has been designated and written for a later spin-off series of his own (Black and Halle). The series Black and Halle features Black starring as the street thug Kingpin who gains political affluence, through his lifelong sweetheart Halle (also starring in Pro Se Litigator series), who is a prominent D.C. attorney who has established her own well-known Law Firm.

"THE TAKEDOWN"

"THE HARSH REALITY OF THE JOURNEY"

Antoine comes to grips with himself, his arrest, and his obvious destiny. The cards are stacked, nobody plays fair, and he must fight for his physical life in the D.C. Jail. He also must fight just as hard for his liberty against a corrupt legal system that went as far as kidnapping Antoine and placing a bounty on him, via the MS-13 gang.



"WELCOME TO HELL, MR. JONES"

Antoine undergoes a true ordeal of hell on earth while in the D.C. Jail fighting for his life in the legal arena. First, Hector, the leader of the MS-13 gang who had previously put out a failed hit on Antoine. When Hector is allowed out of lock-up and continues his "get Antoine Jones" business, as he had originally planned. Antoine's and Hector's runin results in a hand-to-hand gladiator style combat. Next, Antoine survives and dodges the ruthless murderous crew of Krazy Dee, only to find himself stabbed in the back by his African American friends (co-defendants). At the same time, Antoine was being crossed by the attorneys of his Mexican Cartel co-defendant, so that their clients can get out of hot water. Through it all, Antoine prays for strength to endure and fight!



"PULLING THROUGH BY GOD'S GRACE"

Antoine struggles to truly learn his case, comprehend the law, and prepare for trial. AUSA Rhonda Lewinski pursues a "by any means necessary" type of prosecution, resulting in a failed murder attempt on Antoine, by a Hispanic gang. Unexpectedly, numerous people flip, that resulted in the debriefing of Jones' co-defendants. The quest to destroy Antoine went as low as the federal government planting a friendly informant in Antoine's cell, along with several other unethical tactics all aimed to seek, target, and destroy Antoine.



"IF IT WASN'T FOR BAD LUCK, I'LL BE DAMNED"

As if the stress and frustration of preparing for the trial of his life isn't enough, Antoine Jones's association with Black is used by the corrupt figures in Antoine's initial case, which could possibly seal Antoine's fate of doing life in prison. D.C. Jail Federal racketeering charges are suddenly looming, with Antoine Jones being suspected as a top behind-the-scenes figure who may be charged in a superseding indictment.



"SHOCKING REALITY"

The government slips and Antoine attempts to capitalize from the loophole to get his case dismissed and gain his freedom. Meanwhile, Antoine is oblivious to two things: One, that his days in D.C. Jail may be numbered by the MS-13 gang leader who has ordered Antoine to be killed. Two, Antoine's attorney uses tactics of threatening Antoine with the possibility of a repeat offender sentence, that increases to life if he refuses to plead guilty and goes to trial.



"THE DOUBLE CROSS"

All is going well in the Antoine Jones case. Jury selection resulted in a "dream jury." Opening arguments were great and the start of the trial was perfect. It suddenly changed when Antoine's defense was blind-sided by each of his co-defendants' attorneys, who used an antagonistic defense, damaging Antoine far worst, then the Government had already done. In an effort to assist Antoine's defense, his co-defendants show their loyalty to Antoine by scolding their attorneys. Meanwhile, Black brings the radar on him and others when two key Government witnesses turn up dead, just before Black's criminal trial.



"A TRIAL DREAM COME TRUE"

Attorney Mesa tactfully turns the Government's case into a living nightmare when he outright exposes the perjury of Agent Yarny. The exposure caused Judge Howard to recuse Yarny, by ordering her off the witness stand. Making the government's day worst, was having key witness Alfred Goings' take the stand claiming he had multi-kilogram dealings with Antoine. He is exposed when Goings is asked to identify Antoine Jones and misidentifies Antoine in two different attempts. The entire courtroom watches in shock from the judge, jury, and everyone else in the courtroom.



"STRESSED OUT"

Antoine's stress capacity is pushed far beyond the breaking point when government key witness Jay Alexanders' testimony pierces Antoine's heart, as Jay brags about how he damaged Antoine, during his trial to other informants on his unit. At the same time, the government conspires to name Antoine as a number one suspect in Black's criminal investigation, where two key witnesses had been murdered.



"UNFINISHED BUSINESS"

Antoine Jones, Black, and Hector return to the unit, from the South One lock-up unit. Hector has stopped the hit on Antoine, but tension still fills the air due to an unknown perpetrator, who seeks out gay inmates and murders them.



"GOOD NEWS FOR SOME, BAD FOR OTHERS"

The Club Levels Crew concludes their awesome defense and receive acquittals, while Halle Jenkins and her law firm partners are taken down by the Government on serious criminal drug charges. This occurrence shocks legal firms, throughout Washington, D.C.
